THE CORPORATION OF THE CITY OF THUNDER BAY

BY-LAW NUMBER 236.. 1985.....

A By-law to amend By-law Number 147-1985 of The Corporation of the City of Thunder Bay.

WHEREAS it is advisable and expedient to amend By-law Number 147-1985 of The Corporation of the City of Thunder Bay as hereinafter provided;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF THUNDER BAY ENACTS AS FOLLOWS:

1. By-law Number 147-1985 of the Corporation is hereby amended by deleting Paragraph 2 thereof and substituting the following therefor:

"2. The property more particularly described as follows,

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Fort William, now the City of Thunder Bay, in the District of Thunder Bay, in the Province of Ontario and being composed of that part of Lot Number Two (2), Concession Two (2), of the Township of Neebing described as follows:

COMMENCING at a point in the westerly limit of Selkirk Street where the same is intersected by the westerly production of the southerly limit of McGregor Avenue, as the said street and the avenue are shown on a plan filed as Number 393 in the Registry Office for the Registry Division of Thunder Bay;

THENCE westerly along the said production one hundred and fifty-eight and five tenths feet (158.5');

THENCE southerly and parallel to the said limit of Selkirk Street, two hundred and thirty-one feet (231') to a point in the westerly production of the northerly limit of Isabella Street, as shown on the said plan;

THENCE easterly along the said production of the limit of Isabella Street, one hundred and fifty-eight and five tenths feet (158.5') to the said limit of Selkirk Street;

THENCE northerly along the last mentioned limit, two hundred and thirty-one feet (231'), more or less to the point of commencement,

TOGETHER WITH a right-of-way at all times in common with others entitled thereto, over, along, and upon a strip of land fourteen feet (14') in perpendicular width immediately adjoining the westerly limit of the hereinbefore described parcel, and extending southerly from the said westerly production of the southerly limit of McGregor Avenue to the said westerly production of the northerly limit of Isabella Street,

AS DESCRIBED IN INSTRUMENT NUMBER 5611-D,

is hereby designated as property of historic or architectural value or interest pursuant to Part IV of The Ontario Heritage Act, Statutes of Ontario, 1974, Chapter 122."
